During the hearing sessions for the examination of the Nottinghamshire and Nottingham Waste Local Plan on Tuesday 15th and Wednesday 16th October 2024, a number of potential main and additional modifications were discussed. This included the proposed <u>main modifications</u> (document EXAM 3) and <u>additional modifications</u> (document EXAM 2) the Councils proposed prior to the hearings as well as further potential main and additional modifications that arose during the course of discussions.

As detailed in the <u>Inspectors Post Hearing Note</u> (document EXAM 11) the Councils maintained a running list of the potential main and additional modifications and actions that arose during the discussions. The table below summarises these main and additional modifications and post hearing actions.

Please note that the table below does not provide the detailed wording of the potential main and additional modifications but provides an outline of where further modifications will be made to the Pre-Submission Draft Version of the Nottinghamshire and Nottingham Waste Local Plan (document CD1). Please note these are in addition to the already proposed main and additional modifications as detailed in EXAM 2 and EXAM 3.

The next steps and indicative timetable are set out within the <u>Inspectors Post Hearing Note</u> (EXAM 11), with the detailed modifications published for consultation expected in January/ February 2025.
